

PRIVACY NOTICE – DEPUTY / ATTORNEY / APPOINTEE

Under Articles 13 and 14 of the General Data Protection Regulations organisations are required to provide people with information about the intended purposes for processing personal data and the lawful basis, or bases, for the processing.

- Aspirations Care Ltd, Aspirations (Midlands) Ltd and New Start Supported Housing Ltd are not required to appoint a Data Protection Officer
- The purpose of processing is providing support
- The lawful bases of processing are **Contract** for legally appointed Deputies and Attornies and **Legitimate Interests** for Appointees who have not been legally appointed; for the latter, a Legitimate Interest Assessment has been carried out
- Personal data may include:
 - Name, contact details
 - Bank detailsThis list is indicative and not exhaustive
- Personal data may be shared between Group companies, our outsourced IT partner and law enforcement/government authorities
- Personal data is not transferred to third countries
- Personal data is not used or shared for marketing purposes
- Unless the Service User's personal data is transferred to their funding Local Authority when support ceases, it will be retained for a minimum of 6 years following Aspirations ceasing to provide support
- The General Data Protection Regulations provide the following rights for individuals:
 - The right to be informed
 - The right of access
 - The right to rectification
 - The right to erasure

- The right to restrict processing
 - The right to data portability
 - The right to object
 - Rights in relation to automated decision-making and profiling**
- Not all rights relate to all types of data
 - ** The Aspirations Group of companies does not carry out automated decision-making and profiling
